1.0 INTRODUCTION

Pinchin Ltd. (Pinchin) was retained by the Township of McGarry (the Township) to complete a Waste Capacity Assessment (WCA) for the McGarry Waste Disposal Site (the Site) located in McGarry, Ontario. The purpose of completing the WCA was to determine the existing and remaining waste capacity of the Site. This WCA is also intended to support an evaluation of lifespan for the Site via the calculation of the estimated annual waste deposition rate.

1.1 Scope of Work

The scope of work to be completed for the waste capacity study is outlined in Pinchin's proposal entitled "Proposal for Aerial UAV/RPAS Topographic Survey and Waste Capacity Review, McGarry Waste Disposal Site, Virginiatown, Ontario", dated January 7, 2022. The scope of work completed by Pinchin included the following:

1.1.1 Topographic Survey

- Pinchin completed a topographic drone survey to document the current Site conditions
 through the collection of georeferenced imagery. The unmanned aerial vehicle (UAV) is
 capable of covering vast amounts of terrain through waypoint flight plans to capture high
 resolution images for further processing;
- The images obtained from the UAV were used to develop a digital elevation model and Digital Terrain Model (DTM); and
- A waste volume calculation was estimated using the information collected during the during the UAV topographic survey.

1.1.2 Waste Capacity Assessment

A waste capacity assessment was prepared containing:

- A summary of background and analysis of available information on the Site as it relates to capacity;
- An analysis of the 2022 topographical survey;
- An estimated annual deposition rate; and,
- A summary of findings including the remaining Site life in years (theoretical lifespan),
 calculation of remaining years until the Site reaches capacity based on the estimated deposition rate.

1.2 Background

1.2.1 Site Document Review

Pinchin reviewed the following historical reports for the Site and are referenced within this document:

 (the 2013 Thomas Guo Memo);

1.2.2 Site Location

The Site is located approximately 4 kilometres (km) east of Virginiatown, Ontario, along the border between Québec and Ontario. The Site is accessed via a gravel road that extends off Raven Mountain Road, south of Highway 66. The area that the Site is situated in is a rural setting where land use within 1 km of the Site is predominantly vacant forested Crown land. The former Raven Mountain Ski Facility area is located approximately 1 km southwest and Highway 66 is approximately 1 km north of the Site.

The Site is located at Universal Transverse Mercator (UTM) coordinates Zone 17U, 609,800 metres (m) Easting and 5,332,529 m Northing (North American Datum (NAD) 1983). Landfill coordinates were obtained from Google Earth.

The Site location is presented on Figure 1 (All Figures are provided in Appendix I).

1.2.3 Geological Conditions

The Site is located on the boundary of an esker which consists of sand and gravel deposits approximately 100 m thick, deposited by glacial meltwater that was flowing beneath or within the glacier. The quaternary geology of the Site is mapped as Cenozoic Glaciolacustrine shallow water deposits of sand with minor gravel. This sand is typically fine to medium grained although silty and/or coarse layers are commonly encountered. Based on Pinchin's review of the boreholes advanced at the Site, the soil consists of medium grained and silty sand.

The topography of the Site gently slopes toward the middle of the Site and westward toward the Milky Creek drainage area. Milky Creek is located approximately 500 m west of the Site. The landfill area is located in the drainage area of a tributary to Milky Creek. Pit development and sand extraction has resulted in a flat, level site for fill placement surrounded by a sand bluff. An average topographic surface elevation of 320.5 meters below sea level (masl) was identified across the areas of the Site inferred to be undisturbed by historical waste fill operations.

1.2.4 Site Description and Development

This Site was originally approved in 1973 for the use and operation of a landfill site for the disposal of solid, non-hazardous domestic and commercial wastes. According to the "Operation and Maintenance Manual for McGarry Landfill" prepared by Hatch Ltd. (Hatch) dated August 12, 1999 (the 1999 Design and Operations Plan (D&O) Plan). The 1999 D&O Plan states that the Township had been transferred a 7.43 hectare (ha) property earlier in the year by the Ministry of Natural Resources (MNR), comprising the southern portion of a former sand and gravel extraction pit and some adjacent land. The walls of the pit, prior to landfilling, were reportedly 3 to 3.6 metres high, and the base reportedly comprised of silty sand.

The original Site D&O Plan was reportedly prepared by Heathwood Engineering Associated Limited. The Site is operated under Ministry of the Environment, Conservation and Parks (MECP) Provisional Certificate of Approval (CofA, now referred to as an Environmental Compliance Approval (ECA)) Number A572402, issued August 20, 1980, for a 35 ha landfilling site for the disposal of solid, non-hazardous domestic and commercial wastes. A copy of the most recent CofA is provided in Appendix II. The Site is also subject to Ontario Regulation 347 and the existing requirements under the *Environmental Protection Act*. Waste disposal is limited to that generated and collected from the communities of Kearns and Virginiatown.

While it is not explicitly stated within files available to Pinchin for review, satellite imagery from December 1985 suggests that the increased Site area to 35 ha with the Provisional CofA encompassed the remainder of the sand and gravel extraction pits, north of the southern extraction pit comprising the initial 7.43 ha property transferred to the Township. The CofA indicates that the Site is to be operated in accordance with a Site Plan dated February 8, 1977, and a Surveyor's Certificate prepared by Pit, Blackburn, Ontario Land Surveyors dated July 2, 1974. These documents have not been provided to Pinchin for review at the time of preparation of this report.

On October 29, 1998, the MECP issued an Inspection Report that included a request that the Township update their Site Plan and their Operational and Maintenance Plan as an action item, this request had also been requested during previous inspections. It is Pinchin's understanding that the 1999 D&O Plan is the current approved D&O Plan for the Site.

Hatch outlines four distinct fill areas in their 1999 D&O Plan, a large primary area at the south side of the Site (fill area 1), a small abandoned area at the southwest side of the Site (fill area 2), a fill area at the northeast end of the Site for scrap metal storage (fill area 3), and a fill area on the north end of the Site (northeast of fill area 1) designated for the disposal of demolitions materials (fill area 4). Landfilling was progressing from fill area 1 northward towards fill area 4 in 1999. Hatch states that all cover material is taken from the banks of the pit. A drainage ditch was excavated in May 1999 to address localized ponding at the western toe of fill area 1, redirecting surface runoff westward and improve site drainage. The Site boundary was cleared in the fall of 1998. This work involved clearing the entire perimeter (property line) of the Site to improve site definition, access and regulatory compliance.

In 2014, the MECP conducted a groundwater-related review of the 2013 annual monitoring report prepared by A&A Environmental Consultants Inc. (A&A) for the Site to evaluate on and off-Site groundwater impacts, as well as compliance with provincial regulations. The review was summarized in the 2014 Thomas Guo Memo. Mr. Guo indicated that contaminated leachate was migrating off the established contaminant attenuation zone (CAZ) for the Site. Based on this conclusion, it was recommended that the Township investigate mitigation measures, including expanding the CAZ with additional downgradient land and replacing the assumed background monitoring well (MW1) with a new background monitoring well.

On January 21, 2016, Pinchin submitted a Voluntary Abatement Plan to the Township, outlining a comprehensive three-year strategy aimed at supporting the Township's long-term waste disposal needs, addressing MECP concerns and ensuring economic feasibility. As part of the plan's implementation, several key actions were undertaken, including an Environmental Peer Review and Operations Evaluation to assess historical Site impacts and regulatory compliance, the completion of Annual Monitoring Programs and Reports from 2016 to 2020, a monitoring well elevation survey, the

development of a Design and Operations (D&O) Plan along with a Waste Capacity Assessment, and the preparation of an updated Voluntary Abatement Plan. The design incorporated a maximum slope of 4:1 (horizontal to vertical) and a minimum slope of 20:1 to facilitate proper drainage and long-term site stability. The D&O Plan states that the buffer area at the Site consists of wooded, undeveloped areas, however, a formal CAZ has not been established for the Site.

2.0 WASTE AREAS AND VOLUMES

2.1 Previous Waste Capacity Assessments

A waste capacity assessment was originally performed in the "Site Design and Operations Plan for McGarry Sanitary Landfilf" prepared by Hatch Ltd. (Hatch) dated August 12, 1999. Based on survey work conducted by Hatch in December 1998, they estimated that approximately 76,120 cubic meters (m³) or 27,403 tonnes (based on a specific weight of 360 kg/m³ of compacted solid waste) had been landfilled. The remaining landfill Site capacity was estimated to be 24,000 m³ or 8,650 tonnes of compacted solid waste, based on their survey results and a 4:1 waste to cover ratio. A remaining lifespan of 19 years was estimated using a weekly disposal rate of 7 tonnes of uncompacted waste (based on a specific weight estimated of 200 kg/m³ of uncompacted solid waste).

Since there is no permitted volume specified within the CofA, the 2017 D&O Plan specifies that the available capacity remaining at the Site is therefore dependent upon the 35 ha area approved for landfilling. Based on information provided by the Township, the 2017 D&O Plan reports that the majority of the waste deposited at the Site is collected at roadside once a week using a 9-yard compacting garbage truck and typically two full loads of compacted garbage is collected (approximately 14 m³ per week). Based on this estimate, an annual collection rate of 730 m³ per year was estimated. A remaining landfill lifespan was estimated to exceed 75 years by Pinchin, subject to periodic reviews and operational adjustments.

The 2019 Liability Estimate states that a revised waste capacity estimate was calculated using the available data from the 2017 D&O plan, resulting in an estimated 202,914 m³ of existing fill. The report divides the Site into an approximate 15.4 ha area on the west end and an approximate 19.6 ha area on the east end with final slope contours of 4 horizontal to 1 vertical (4:1) and 20:1, respectively. Using these slope constraints and the full 35-hectare permitted footprint, the theoretical maximum fill volume was recalculated using a fill height of 2 m for the western area and a fill height of 3 m for the eastern portion of the Site, was calculated to be 811,656 m³.

2.2 Updated Waste Capacity Assessment

2.2.1 Topographic Survey

Pinchin completed the topographic survey of the Site on August 17, 2022. Using a Transport Canada Compliant UAV/RPAS, the DJI Matrice M300 enterprise-grade UAV consisting of a rotary wing platform equipped with a DJI P1 high resolution RGB camera and an Emlid RS2 GNSS RTK base station. Pinchin surveyed the location of the waste deposits, access road, major landmarks and surficial topography. The results of the survey data were utilized to support the waste capacity calculations for the Site. Civil3D was utilized to process the UAV data and produce a 3D model. Global Mapper was then used to generate a DTM and topographic contours. The Site topography from the 2022 survey is illustrated on Figure 2.

2.2.2 In-Place Volume

As discussed in Section 1.2.4, the landfill was originally developed by infilling the former sand and gravel excavations in the pit base and the fill area advanced by pulling material from the pit edge for waste cover. Thus, using the August 2022 aerial UAV survey and identifying the assumed historical waste areas and an estimated an average of 3.3 m of waste below the inferred natural Site grade (i.e., 320.5 masl), a new in-place waste estimate of 231,605 m³ was determined.

2.2.3 Remaining Capacity and Fill Rate

Comparing the estimated in-place volume to the previously estimated total Site capacity of 811,656 m³, gives a total remaining available capacity estimate for waste deposition at the Site of 580,051 m³ (as of 2022) However, as a result of the revised historical fill area footprints differing between the 2017 D&O Plan, comparing the estimated 202,914 m³ of existing fill to the recent estimate of 231,605 m³ is not considered a viable option for determining the average annual waste deposition. The annual collection rate of 730 m³ per year estimated in the 2017 D&O Plan also appears to be fairly high based on the population size and the rate of waste filling observed at the Site. Accordingly, the average annual waste deposition volume was calculated according to the available population statistics. In 2021, the Township population was 579, according to Statistics Canada; which was a 4.9 percent decrease in residents between 2016 and 2021. Using an average per capita waste generation rate of 1 kg/person/day, the 2021 population of 579 residents, an "airspace utilization factor" of 593 kg/m³ for compacted solid waste (a specific waste density of 593 kg/m³ provided in the 2019 Liability Report) and a 4:1 waste to cover ratio (including interim and final cover material) results in a fill rate of approximately 445.5 m³ per year according to 2021 population estimates.

Based on these projections the current 2025 in place volume is estimated to be approximately 232,942 m³, resulting in a remaining capacity of approximately 578,715 m³.

2.2.4 Lifespan

Utilizing the value estimated for remaining available waste disposal volume (578,715 m³) and the average annual waste deposition rate (approximately 445.5 m³ per year), the estimated remaining theoretical lifespan of the Site (based solely on volume capacity) is in excess of 100 years, as of August 2025. It is important to note that waste deposition is somewhat variable, resulting in changes to the average annual deposition rate used to calculate remaining site life. The remaining site lifespan estimate assumes that the waste deposition rate remains constant, and that the Site is developed to the maximum capacity assumptions of this assessment. It is recommended that regular annual topographic surveys of the waste disposal area be undertaken in order to more accurately estimate the average annual waste deposition rate if additional accuracy pertaining to the Site life estimates are required.

3.0 CONCLUSIONS

The following is a summary of the findings of the WCA:

- The Site has a 35 ha permitted footprint to be utilized for disposal of solid, non-hazardous domestic and commercial waste;
- Per the 2019 Liability Estimate, the theoretical maximum fill volume was calculated to be 811,656 m³, using the proposed slope and height constraints (2 m height at 4:1 slope and 3 m height at 20:1 slope);
- The current remaining capacity of the Site has been estimated as approximately 578,715 m³;
- Using population statistics, Pinchin has assumed an average annual deposition rate of approximately 446 m³ of waste material (compacted waste and cover material) per year; and
- Based on the estimated remaining capacity of 578,715 m³, and the average annual estimated deposition rate of waste material of approximately 446 m³ per year, the estimated remaining life span of the Site is over 100 years.

4.0 LIMITATIONS

This WCA was performed for the Township of McGarry (Client) in order to investigate the remaining capacity at the McGarry Waste Disposal Site (Site). The term recognized environmental condition means the presence or likely presence of any hazardous substance on a property under conditions that indicate an existing release, past release, or a material threat of a release of a hazardous substance into structures on the property or into the ground, groundwater, or surface water of the property. This WCA

does not quantify the extent of the current and/or recognized environmental condition or the cost of any remediation or corrective measure.

Conclusions derived are specific to the immediate area of study and cannot be extrapolated extensively away from sample or test pitting locations.

No environmental site assessment can wholly eliminate uncertainty regarding the potential for recognized environmental conditions on a property. Performance of this WCA to the standards established by Pinchin is intended to reduce but not eliminate uncertainty regarding the potential for recognized environmental conditions on the Site and recognizes reasonable limits on time and cost.





This report provides an overview of the current status, and operational concerns facing the following standing committees:

It is intended to support council discussion and decision-making regarding committee viability, volunteer shortages, and the sustainability of planned events and initiatives.

General Member Update

At this time, all three committees are short of members, with several key resignations having occurred in recent weeks. One committee member has stepped down from all committee roles, citing a lack of time to commit to ongoing responsibilities. Current Committee Members

Following the recent resignation, the Recreation Committee now consists of:

- One active member
- Chair and Co-Chair

This leaves 3 people responsible for planning and running upcoming events, a situation that is **not sustainable**.

Concerns

• Event Supervision and Safety:

Events such as the Halloween Dance for children require adequate adult supervision to ensure safety. Although there are no strict guidelines on supervisor-to-child ratios, the township would remain **liable** in the event of an incident

• Committee Viability:

The Recreation Committee is experiencing rapid member turnover and unfilled vacancies. Without sufficient support, its ability to safely and effectively offer community events is in jeopardy.

Recommendations

Council is asked to discuss and provide guidance on:

- Whether planned events should proceed under current conditions
- Whether to pause events temporarily until the committee is adequately staffed

Conclusion

All three standing committees — Recreation, Tourism, and Strategic Planning — are currently facing **critical membership shortages**, due in part to recent resignations and ongoing difficulties recruiting volunteers.

This situation compromises the committees' ability to:

- Plan and deliver events
- Maintain safety and accountability
- Fulfill their mandates effectively

Council action is urgently required to address volunteer shortages, determine the future of planned events, and consider whether temporary suspensions or restructuring are needed.
