

THE CORPORATION OF THE TOWNSHIP OF MCGARRY

BY-LAW NO. 94-13

Being a by-law to appoint a Clerk-Treasurer

WHEREAS THE MUNICIPAL ACT, R.S.O. 1990 Chapter M45, Sections 73(1) and 77(1) provides that the council shall appoint a clerk and shall appoint a treasurer who shall perform the duties of clerk and treasurer as outlined in the Municipal Act and other Acts of the Legislature of Ontario

NOW THEREFORE the Council of the Corporation of the Township of McGarry enacts as follows:

1. That Ardene Lefebvre be and is hereby appointed Clerk-Treasurer for the Corporation of the Township of McGarry effective January 1, 1995.
2. That Ardene Lefebvre will be on probation as Clerk-Treasurer from January 1, 1995 to June 30, 1995.
3. That Ardene Lefebvre shall perform all the duties required to be performed by clerks and treasurers under any statutory authority and any other duties which may, from time to time, be imposed by Council.
4. That the salary of Ardene Lefebvre be payment in full for all services required of her and all fees and emoluments of any kind accruing to her by virtue of any act, statute or by-law shall be paid to the Township and be credited to the general fund of the Township of McGarry.
5. That by-law No. 376 duly enacted and passed by Council on the 13th day of February, 1968 covering the appointment of June Elaine Lamb as Clerk-Treasurer be repealed effective January 1, 1995, together with all by-laws amending by-law No. 376 with regard to increases in salary for the said June Elaine Lamb.


