Being a By-Law to appoint Committee Members and Representatives for the Township of McGarry for the year 2023-2024

Whereas By-Law #2021-57, "Procedural By-Law" provide rules for governing the order and procedures which Council and Committees of Council are to operate and follow; and,

Whereas Council has established committees that are comprised of both members of the public and members of Council; and,

Whereas Council recognizes that throughout the one year term of the Committee new appointments may be required and resignations may be submitted;

Now Therefore the Council of the Corporation of the Township of McGarry enacts as follows:

- a) The list of initial appointments for committee members and representatives for the year 2023-2024 are identified in the attached schedule that is marked Schedule "A" and forms part of this By-Law.
- b) All additional appointment and resignations be approved through the adoption of a resolution;
- c) That this By-Law shall take effect on September 12th, 2023 and that By-Law 2022-44 be repealed.
