**BY-LAW 99-13**

**Being a By-Law to amend By-Law 99-03**

WHEREAS the Council of the Township of McGarry enacted By-Law 99-03, being a By-Law to prohibit the running at large of dogs, for imposing a licence fee on the owners of dogs, and for regulating the disposal of dogs running at large and other matters relating to dogs.

And WHEREAS Schedule "A" of By-Law 99-03 establishes set fines for various offences to By-Law 99-03.

And WHEREAS By-Law 99-03 was submitted to the Ministry of the Attorney General for approval of the set fine portion of the By-Law.

And WHEREAS the Ministry of the Attorney General has requested a revision of Schedule "A" of By-Law 99-03.

NOW, THEREFORE, Council of the Township of McGarry enacts as follows:

- 1) THAT Schedule "A" to By-Law 99-03 be and is hereby repealed.
- 2) THAT Schedule "A" attached to this By-Law shall replace and become Schedule "A" to By-Law 99-03
- 3) THAT this By-Law will come into affect upon final approval of the proposed set fine schedule by the Ministry of the Attorney General.
