
AND WHEREAS Council is desirous to enter into an agreement with the Centre de Santé for the provision of medical services.

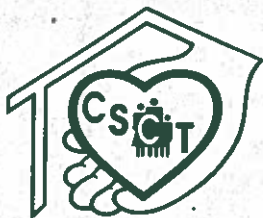
NOW THEREFORE Council of the Township of McGarry enacts as follows;



**Contractual Agreement  
Fiscal year 2007-2008**

**Secretarial Services for Virginiatown**

The Municipality of McGarry agrees to reimburse the Centre de santé communautaire du Témiskaming for 17.5 hours of secretarial services provided during hours of operation in the municipality.

The costs of reimbursement include actual salary rates, employer costs, health care benefits, regular RRSP contributions and relief services.

The municipality will receive quarterly billings for services rendered by the Centre de santé communautaire du Témiskaming. The yearly costs to the municipality will not exceed \$26,500. The Centre de santé will bill exact costs on a quarterly basis.

The Centre de santé communautaire du Témiskaming is the sole employer of the secretary and as such assumes all responsibilities and liabilities as employer.

This agreement is in effect from April 1, 2007 to March 31, 2008.
