#### THE CORPORATION OF THE TOWNSHIP OF MCGARRY

#### **BY-LAW NO. 2010-12**

BEING A BY-LAW TO ESTABLISH A SCHEDULE OF USER FEE'S.

WHEREAS SECTION 391 OF THE MUNICIPAL ACT, 2001, AS AMENDED BY THE MUNICIPAL STATUTE LAW AMENDMENT ACT 2006 AUTHORIZES COUNCIL TO PASS BY-LAWS IMPOSING FEES OR CHARGES FOR SERVICES OR ACTIVITIES PROVIDED OR DONE BY OR ON BEHALF OF THE MUNICIPALITY AND FOR THE USE OF ITS PROPERTY.

AND WHEREAS SECTION 23(3)(2) OF THE MUNICIPAL ACT AUTHORIZES COUNCIL TO DELEGATE BY BY-LAW TO AN EMPLOYEE OF THE MUNICIPALITY, ANY POWERS, DUTIES OR FUNCTIONS THAT ARE ADMINISTRATIVE IN NATURE.

# NOW THEREFORE, COUNCIL OF THE TOWNSHIP OF McGARRY ENACTS AS FOLLOWS:

- 1. THAT the fees and charges set out on the attached schedules are hereby imposed.

  Schedule "A" Equipment
  - Schedule "B" Environmental Services
  - Schedule "C" Corporate Services
  - Schedule "D" Community Services
- 2. Where possible all fees as set out in this By-Law shall be paid before the provision of the service.
- 3. In the event a fee or charge remains unpaid after the provision of a service, such fee's or charges may be added to the Tax Roll in the Municipality, the owner of which is responsible for paying the fee or charge, and shall be collected in a like manner as Municipal Taxes.
- 4. THAT Council does hereby delegate the Clerk-Treasurer the authority to administer the fees and charges imposed and set up such forms and procedures as may be required for administrative purposes.
- 5. The fees and charges set out in this By-Law shall be reviewed on an annual basis.
- 6. The fees and charges laid out in this By-Law shall supersede any existing fees or charges.
- 7. That By-Law 2007-23 be repealed.
- 8. THAT this By-Law shall take effect on the date of its passing.
