- That Section 3.3 of By-Law 2010-20 be and is hereby repealed and shall be replaced 1) with the following;
 - 3.3 No owner shall fail to comply with an order to eliminate or correct standing or stagnant water. Not limiting the foregoing, such order may include a direction to fill or drain off the water or the treatment of the same with larvicide.
- That Schedule "B" to By-Law 2010-20 shall be amended as follows; 2)
 - a) Column 2., of Schedule "B" shall be amended to read "Provision Creating or Defining Offence".
 - b) That item 2 of Schedule "B" shall be amended to read "Fail to comply with an order to eliminate or correct standing or stagnant water".
- That the Heading and General Penalty Provision citations on Schedule "B" to By-Law 3) 2010-20 make reference that they have been amended by By-Law 2010-33.
