**BEING A BY-LAW TO AMEND
BY-LAW 2013-01**

WHEREAS By-Law 2001-03 established pay grids for employee's of the Township of McGarry.

AND WHEREAS By-Law 2013-01 amended the pay grids as established.

AND WHEREAS Council is desirous to establish new rates of pay for its employee's.

NOW THEREFORE Council of the Township McGarry hereby enacts as follows:

1. That By-Law 2013-01, and Schedule "A" attached thereto be and is hereby repealed effective February 23, 2014.
2. That Schedule "A", attached to and forming part of this By-Law shall be the wage/salary grid for Township of McGarry employees' effective the first pay period of March, 2014.
3. That all other provisions of By-Law 2001-03 shall remain in effect.
