BY-LAW NO. 2018-17

BEING A BY-LAW TO NAME A STREET

WHEREAS section 47 of the Municipal Act, 2001 be repealed and amended.

WHEREAS Section 48 of the Municipal Act, 2001 grants Council authority to name public streets.

AND WHEREAS Section 48 of the Municipal Act, 2001 requires a public meeting be held prior to passing a By-Law naming a street.

AND WHEREAS Schedule "1" of By-Law 2007-20 requires certain provisions be complied with before a public meeting is held.

AND WHEREAS notice of public meeting of June 19th, 2018 was given in accordance with the provision of By-Law 2007-20.

NOW THEREFORE Council of the Township of McGarry enacts as follows:

- 1) **THAT** the portion of Government Road that still exists, starting at the Kerr Mine Road intersection to the newly relocated highway 66 intersection as shown on schedule "A" attached to and forming part of the By-Law be renamed Kerr Mine Road.
- 2) **THAT** this By-Law shall be effective after proper road signs are installed.
