

THE CORPORATION OF THE TOWNSHIP OF MCGARRY

BY-LAW NO. 2019 – 24

**A Bylaw to prohibit the depositing of snow
on any highway or bridge within the Township
of McGarry**

WHEREAS the Municipal Act, R.S.O. 2001, Section 11(3) empowers municipalities to pass bylaws regarding highways;

AND WHEREAS the definition of highways includes all streets, travelled public laneways and public sidewalks;

NOW THEREFORE the Council of the Corporation of the Township of McGarry enacts as follows:

1. No person shall deposit or cause to be deposited any snow or ice upon any portion of any highway or bridge located within the territorial limits of the Corporation of the Township of McGarry.
2. No person shall clear away or remove snow from a municipal highway, except as may be necessary to clear away snow blocking access to a private entrance or driveway.
3. No person shall move snow within the street allowance from one side of the cleared portion of the street allowance intended for vehicular and pedestrian traffic, to the other side of the street allowance.
4. No person shall relocate snow within the street allowance in such a manner as to encroach on the cleared portion of the street allowance intended for vehicular and pedestrian traffic, or that would result in the obstruction of normal visibility of the safe movement of vehicular and pedestrian traffic on the street allowance.
5. No person shall deposit snow on or within 1 meter of a fire hydrant
6. No person shall deposit snow onto a neighboring or adjacent property.
7. Any person who contravenes any provision of this Bylaw is guilty of an offence and subject to a fine recoverable under the Provincial Offences Act.
