**Whereas** By-Law #2016-12, “Procedure By-Law” establishes the rules and procedures under which Council and Committees of Council are to operate; and,

**Whereas** Council has established committees that are comprised of both members of the public and members of Council; and,

**Whereas** Council recognizes that throughout the one year term of the Committee new appointments may be required and resignations may be submitted;

**Now Therefore** the Council of the Corporation of the Township of McGarry enacts as follows:

- a) The list of initial appointments for committee members and representatives for the year 2021 are identified in the attached schedule that is marked Schedule “A” and forms part of this By-Law.
- b) All additional appointment and resignations be approved through the adoption of a resolution;
- c) That this By-Law shall take effect on January 1, 2021 and that 2020-46 be repealed.
