Whereas By-Law #2016-12, "Procedure By-Law" establishes the rules and procedures under which Council and Committees of Council are to operate; and,

Whereas Council has established committees that are comprised of both members of the public and members of Council; and,

Whereas Council recognizes that throughout the one year term of the Committee new appointments may be required and resignations may be submitted;


Now Therefore the Council of the Corporation of the Township of McGarry enacts as follows:


