# b) Audience Questions:

- Mr. Clermont Lapointe questioned the decision made during the December 11<sup>th</sup>, 2018 Regular Council Meeting a decision was made to allow for two councillors to attend the 2019 ROMA AGRM & Annual Conference. Mr. Lapointe stated that in previous years typically only the Mayor for the Township would attend due to the costs associated with attending such events. Mayor Matt Reimer responded to the question stating that only one member of the Municipal Council would be attending the annual conference.
- Councillor Annie Toupin-Keft also put forward a question regarding the development of Knitting Group that was expecting to hold their first meeting in the XYZ Club Meeting Room. Councillor Toupin-Keft questioned why permission to use the room was given prior to the matter being brought before the Municipal Council. Councillor Toupin-Keft also stated that permission was required to ensure that all matters of liability were addressed. Councillor Wendy K. Weller responded to the question indicating that the Recreation Committee would not be meeting until January 15<sup>th</sup>, 2019 and therefore the offer was made prematurely in order to accommodate the Knitting Group not realizing that a significant breach of protocol would occur.

# 8. Correspondence Information

a) Ministry of Children, Community and Social Services: The Clerk-Treasurer summarized a letter that was received from the Ministry concerning the District Social Administration Board Governance and Accountability Review Final Report which was commissioned by the previous Provincial Government. The letter indicated that the report spoke to the historical challenges that related to the apportionment of costs amount municipal members and resolving the associated conflicts. Clerk-Treasurer indicated residents

interested in reviewing the report could contact the Municipal Office and a copy would be made available.

- b) Ministry of Finance: The Clerk-Treasurer summarized a letter that was received from the Ministry of Finance. In the letter the Ministry has advised municipalities that details relating to the 2019 Ontario Municipal Partnership Fund will be released as soon as possible once the Provincial Government has had time to complete its review of the Province's financial status. The letter also indicated that legislation will be introduced to address issues relating to fairness for professional firefighters and the efficiency of the arbitration system. The letter also provided information regarding the funding that would be available as a result of the federal excise duty collected on recreational cannabis.
- c) Ministry of Municipal Affairs and Housing: A letter from the Ministry was received indicating that the Provincial Government has launched a broad consultation in order to gather information on how to increase the supply and mix of housing, speed up development timelines and drive down costs. Municipalities will be invited to participate in discussions regarding the Planning Act, the Provincial Policy Statement, the Building Code and other matters.
- d) Stewardship Ontario Thinking Beyond the Box: A letter from Stewardship Ontario was received that provided information regarding monies made available through the Municipal Blue Box Recycling Program. The Clerk-Treasurer reported that the Township of McGarry received \$8,260.00 in 2018 and that the calculation of this payment was based on recycling that was collected in 2017. The Clerk-Treasurer reported that the 2018 revenue collected will be reported in the next newsletter in order to demonstrate that not only does recycling divert waste from our landfill but that there is also a financial benefit that is received. It is also hoped that news of this revenue will encourage residents to increase their efforts to divert from the landfill materials that can be recycled.



After much discussion the matter was put to a vote and Councillor Annie Toupin-Keft requested that a "Recorded Vote" be recorded by the Clerk.

The Clerk-Treasurer explained that the tendering process on a yearly basis was having a negative effect as companies who were not successful in their bid have failed to submit a quote for the following years. The Clerk-Treasurer also explained that the tender would specify that the pricing to renew each year would be revisited if the Township were to experience an unreasonable increase in price from one year to the next. THAT Council hereby approves the submission of an application to the 2019 Canada Summer Jobs Program in order to hire a minimum of 7 summer students.
