Clean and Clear: 0

WHEREAS the Covid-19 pandemic has had a significant financial and operational impacts on Ontario Municipalities;

AND WHEREAS municipalities have had to divert resources towards addressing the immediate needs of the pandemic and maintaining service delivery standards despite evolving restrictions and limited funds;

AND WHEREAS the Government of Ontario has delayed timelines with respect to several pieces of legislation;

AND WHEREAS the Government of Ontario has regulated municipal asset management through O.Reg. 588/17: Asset Management Planning for Municipal Infrastructure under the Infrastructure for Jobs and Prosperity Act, 2015;

AND WHEREAS O. Reg. 588/17 mandates that every municipality shall prepare an asset management plan in respect of its core municipal infrastructure assets by July 1, 2021, and in respect of all its other municipal infrastructure assets by July 1, 2023;

AND WHEREAS the key components of an asset management plan as required by the regulation are:

- 1. Infrastructure asset inventory
- 2. Levels of service
- 3. Lifecycle management and financial strategy

AND WHEREAS there is concern amongst Municipal Finance Officer's Association of Ontario (MFOA) members and their municipalities that current capacity challenge (redeployment of staff and lack of available resources) will result in limitations for purposeful asset management planning;

AND WHEREAS Ontario municipalities do not anticipate the current capacity challenges to be resolved in the short-term;

NOW THEREFORE BE IT RESOLVED that the Township of McGarry supports the MFAO's letter to the Ministry of Infrastructure request a one-year extension of deadlines in O. Reg. 588/17: Asset Management Planning for Municipal Infrastructure under the Infrastructure for Jobs and Prosperity Act, 2015; so that all municipalities planning when capacity challenges are resolved.

WHERAS the Temiskaming Municipal Association (TMA) has entered into an agreement with the District of Temiskaming Social Services Administration Board (DTSSAB) to develop and administer a Community Safety and Well being Plan (CSWBP) for the Municipalities in the District of Temiskaming; and including the Municipalities of Temagami;

AND WHEREAS due the Covid-19 Pandemic the original deadline of January 1, 2021 for the completion of a CSWBP was delayed to July 1, 2021 as announced by the Solicitor General of Ontario;

AND WHEREAS the DTSSAB has advised the TMA that it will be impossible to meet the deadline of July 1, 2021; and has requested the TMS appeal to the Ministry of Communication Safety and Correctional Services (MCSC) to extend the deadline until the Spring of 2022 for the completion of the CSWBP; to provide for the required time to complete and implement the plan;

NOW THEREFORE be it resolved that the Council of the Corporation of the Township of McGarry supports the actions of the TMA in its appeal to the MCSCS to extend the CSWBP current deadline date of July 1, 2021 to Spring 2022;
