Property By-Law Committee:

Good Evening,

We will start with an update from the By-Law Officer for the month of April 2021.

Two (2) By-Laws were sent and accepted by Ontario Court of Justice, a) Municipal By-law 2016-17 Clean and Clear and b) Municipal By-Law 2010-32 Temporary Structures By-Law and have been approved by the Ontario Courts.

Clean and Clear:

One (1) letter has been sent out and the order is in the first 30 days to reply.

By-Law 2016-17 has been approved and the fine schedules, the By-Law Officer is working with the By-Law Committee and will be acting on written complaints of properties not in compliance with Clean and Clear By-Law.

Property By-Law Committee:

Three (3) complaints have been received about abandoned buildings. The complaints are being worked on.

Animal Control:

Complaint about domestic fowl the 30 days letter has been sent.

The OPP are looking after two (2) dog complaints of dog running at large. With non-compliance with orders and fines by the By-Law Officer.

One (1) complaint of aggressive dog and owner has been turned over to the OPP.

One (1) complaint of car parked next to fire hydrant, resolved.

Waterfront and Signage

Many years ago, when the beach was closed by the provincial Health due to tailings signs were posted. Over the years the Municipality has replaced these signs numerous times but vandals keep destroying them.

Thanks to the Lions Club a beach and camp site was opened at Bear Lake. When those claims were sold the new owners closed the campsite.

The Township built a marina and gazebo with signage warning citizens about the tailings. Those signs were also removed by Vandals many times.

The mining Ministry was contacted many times requesting the cleanup of the hazards at the old beach site.

Our recent meeting with the ministry resulted in them contacting the claim owners and demanding that the closure plan be followed and the tailing problem be addressed. The Claims Owner installed the signage currently there and submitted a plan to perform tailings and water chemical tests to determine the action to be taken. These results will be submitted to the ministry and Municipality. We are disappointed that the signs do not contain "NO SWIMMING".

The Ministry of Mines has informed us that a proper Mine Closure Plan will be followed.
