10. New Business:

Whereas developments known as "Boreal Forest Medieval Villages" are being proposed in unincorporated townships within the District of Timiskaming; and

Whereas the developers of these "villages" are promoting the fact their developments are not subject to zoning by-laws, building permits, planning policies or other municipal/provincial regulations; and

Whereas the Provincial Policy Statement, 2020 states "in territories without municipal organization the focus of development activity shall be related to the sustainable management or use of resources and resource-based recreational uses"; and

Whereas the Provincial Policy Statement, 2020 further states that the development of new permanent townsites within territories without municipal organization shall not be permitted; and

Whereas matters relating to territories without municipal organization are under the sole jurisdiction of the Province of Ontario; and

Whereas the scale of these developments in the unincorporated townships poses a significant concern for the incorporated municipalities in the District of Timiskaming including;

- Demand for services such as landfill, fire protection, police protection and social services;
- Increase demand on our emergency and medical services such as EMS and local hospitals (who are already dealing with capacity issues);
- Environmental impacts to watersheds and groundwater sources.

Now therefore be it resolved that the Township of McGarry hereby petitions the Honourable Steve Clark, Minister of Municipal Affairs and Housing to immediately enact a Minister's Zoning Order under the Planning Act for each of the proposed "Boreal Forest Medieval Village" developments in order to ensure proper planning principles are being adhered to by the developers and that their developments are consistent with the Provincial Policy Statement, 2020; and

Further that a copy of this resolution be forward to the Honourable David Piccini, Minister of the Environment, Conservation & Parks; the Honourable Greg Rickford, Minister of Northern Development, Mines Natural Resources & Forestry; John Vanthof, MPP for Timiskaming-Cochrane; the Temiskaming Municipal Association; the Temiskaming Mayors' Action Group; and the Federation of Northern Ontario Municipalities.

13. a) Submitted Questions:

Question #1 submitted by Francine Plante

Can the mayor and Council explain as to why in 2021 the municipality held 17 Special meetings close to the public, and the number 17 does not include the closed session in the regular council meetings.

According to the Ombudsman Open meeting guide for municipalities it clearly states that (A municipal or local board meeting, or part of a meeting, MAY be closed to the public If the subject of the meeting falls within one of the 14 exceptions set out in section 239 of the Act. Further down the guide it states: Must meeting be closed if they fall within those exceptions...NOT ALWAYS, in fact, 12 of the 14 exceptions are DISCRETIONARY, meaning that whenever possible, municipalities should opt to discuss these subjects in public, in the interest of transparency. The legislation leaves them the flexibility to keep the doors open.

The Mayor replied: Thank you for your question: Council held Regular and Special Council meeting which are all open to the Public and posted on our website, some of those meetings require a Close Session. Meetings are necessary in order for Council to make important decisions while always keeping the best interest of the residents in mind and for business to continue to move forward. Due to unforeseen circumstances and some very complex issues this past year or so, Council required to meet more than the normal.

In 2019, there was some changes made to the Municipal Act, under Section 270 (5). Council must try to ensure that they are accountable to the public for their actions and the municipality must try to ensure that its actions are transparent to the public. Council is also required to conform to confidentiality within certain matters. For these reasons, extra Special Meetings and some closed sessions were necessary. These closed sessions include various subjects that fall under section 239 of the municipal act such as but not limited to: security of the property of the municipality or local boards; personal matter about an identifiable individual, including municipal board or local board employees, labour relations or employee negotiations, litigation or potential litigation, including matters before administrative tribunals affecting the municipality or local boards; advice that is subject to solicitor-client privilege, including communication necessary for that purpose, acquisition of land etc....

Council has a duty to be transparent to the public and this is why Council and Committee meetings take place regularly. The Township of McGarry encourages and welcomes our residents to attend. The meeting dates and times are always posted on our website in advance.

Anyone wishing to make a complaint should first seek resolution through the Township's internal complaint process. If you are not happy with the outcome of your complaint, you can submit a complaint with the Provincial Ombudsman's Office or with the Integrity Commissioner.

The Mayor also mentioned that Council does not want to be liable for breaching confidentiality as this could result in a lawsuit.

Question #2 submitted by Francine Plante

Can the Mayor and Council explain the approval of \$40,000.00 in the 2021 budget for lawyers' fees when in previous years the amounts varied between \$12,000.00 to \$14,0000.00. That is quite a dramatic increase for taxpayers.

The Mayor replied: The Mayor and Council were aware that the legal fees would be increasing in 2021, and made sure to budget accordingly in order for the budget to read as accurate as possible. Again, due to the special circumstances outlined in Question #1, the required legal fee budget was increased. This was an extraordinary year and Mayor and Council dealt with everything to the best of their abilities, again always keeping in mind the best interest of the residents.

He also mentioned that legal advice is required to deal with certain issues and to avoid liabilities that could bring extra cost to the taxpayers.
